I have chosen to participate voluntarily in the Program. I understand that my family stands to benefit from a more comfortable home and lower gas bills. In exchange for accepting the Program upgrades **free-of-cost**, I agree to ensure that they are all properly maintained.

I have not relied upon any advice or representations from EnviroCentre in deciding to participate or to sign this document, and I certify that I am at least 18 years of age.

I hereby indemnify and save harmless EnviroCentre against any damages, costs or expenses or any claim, action, suit or other proceeding which it may at any time incur or suffer as a result of or arising out of any injury to persons or loss of or damage to property of others which may be or be alleged to be caused by or suffered as a result of this Program, except that EnviroCentre shall not claim indemnity under this section to the extent that the injury, loss or damage has been caused by its negligence or that of its servants and agents.

In the event that EnviroCentre makes small holes in my walls or ceilings to improve the insulation, I agree to look after the finishing work after EnviroCentre has plugged those holes.
